




We are aware about some of the challenges of 21st Century. The challenges are:

PROFILE OF THE COLLEGE.

Now, he has shifted his attention from steel to noble education and has given birth to an Engineering College titled "Durgapur Institution of Advanced Technology and Management" in 2002 with extremlly relevant subjects like Computer Science , Information Technology . Electronics and Communication, Chemical , Mechanical and Electrical Engineering and later on, he has established "Management Institute of Durrgapur" imparting teaching in BBA,BCA,BHM,MBA,MCA in 2003, Manisha International School, offering a CBSE Curriculum based coed 10 + 2 school. Gouri Devi Hospital & Research Institute of Nursing School , Offering Diploma in GNM , Gouri Devi privet industrial training institute offering chain of electrician , Fitter , Draftsman civil & Gouri Devi Hospital & Research Institute affering best facility at attordable charges , Durgapur Which is believed to be introduced from the session 2016-17.

The college is situated on the side of grand trunk road, NH-2 it is 05km away from Panagarh Rlilway station & 02 km. away from Rajbandh railway station only 2 hour journey is enough to reach this modern unit of quality education, Law College Durgapur from Kolkata.

COURSES OFFERED

The Law College Durgapur is the first self financed Law College affiliated to the University of Burdwan, which is presently offering following professional courses under jurisdiction & with affiliation from the Kazi Nazrul University.



• LL.B(HONS): Three- year Degree Course:

Primarily the college was started with a 3 year LL.B(H) degree course from session 2005. The course shall be spread over three academic session from January to December divided into six semester, i.e, from January to june and july to December every year and there shall be semester – wise examination respectively at the end of each semester . the medium of instruction and examination of the course shall be English only.

• B.A.LL.B (HONS.): Five Year Integrated Degree Course:

Besides 3-year LL.B(Hons) Course of studies the College had introduced 5 years integrated B.A.LLB(HONS) Degree course from academic session 2006-07. The course shall be spread over five academic sessions, from July to June, divided into ten Sesmester i.e, from July to December and January to June every year and there shall be semester – wise examinations at the end of each semester . the medium of instruction and examination of the course shall be English only.

• M.S.W: Two year Post Graduate degree course:

From academic session 2008-09 the college had introduced another extremely relevant PG Course of studies, MSW,i.e Master of Social Work running smoothly under the aegis of LCD. Entire two year PG course of studies divided into four Semester, starting from July to June every year and there shall be semester — wise examination at the end of each semester. The medium of instruction and examination of the course shall be English only.

Eligibility and Admission

• LL.B.(Hons)-Three year Degree Course:

The minimum qualification for admission in this course is a graduate degree in (10+2+3 pattern) in any discipline with min.45% marks in aggregate for General category and 40% for SC and ST & 42% for OBC candidates from any recognized university. There is no age bar for admission to the course of studies.

Affiliating University decides the mode of admission in the course from time to time.

• B.A.LL.B.(Hons) Five Year Integrated Degree Course:



The Minimum qualification for this course is 10+2 examination having passed with minimum 45% marks in aggregate for General category and 40% for SC and ST category & 45% for OBC category from any recognized council/ Board. The candidates are required to purchase the form, Law College Durgapur office and submit the duly filled in form to the same office within stipulated date. After verification of forms a short list of the candidates will be published on the basis of marks obtained in 10+2 level in Kazi Nazrul University. The enlisted candidates are required to contact college authority for taking admission. There is no age bar for admission to this course of studies.

 Seat Reservation: The College maintains the reservation policy of seats as per Govt. rule. However, the college management reserves the right of discretions in this matter if required number of candidates are not available against the reserved seats.

Student Facilities

Students are the prime subjects and their welfare and betterment are the sole object of the college and that is why LCD provides best facilities to its student, It provides railway concession forms(as per railway authority norms) to the bonafide students and free internet access to all for minute updation of legal development and charges.

It provides free internet facility for the students to access and interact with Law enriched sites in order to enrich themselves with day to day changes in legal fields and to go through the up-to minute judgments / decisions of Supreme Court or High Courts. Court-Visit Programme:

Legal Aid & Awareness camp



Legal aid programmes are part of social legislation to ensure social justice. Keeping this in view legal and awareness programmes are held with active cooperation of district legal and service authority in august presence and participation of hon'ble ministers, judges, senior advocates ,teachers and social activists.

<u>Cultural Activities</u>: Annual fests and various cultural programmes like celebration of Independence Day Republic Day, Rabindra Jayanti and many other cultural programmes are held throughout the year to break the monotony of the students and to develop the sense of fraternity.



<u>Social Audit</u>: Students of M.S.W regularly participate in Social Audit (NREGA) programs conducted by Govt. of West Bengal.

Institution Rules and Regulations

- ♣ Classes are held according to class routine from 10.20am to 4.00 pm and therefore compulsory. Remedial classes are up to 4.45 pm.
- ♣ Students have to pay semester fees at the beginning each semester. A fine of rs.25 per day shall be imposed to all payments after the stipulated date of payment subject to a maximum of Rs. 16950 per semester. A duplicate may be issued in case of loss or damage of Identify Card, Library Card upon submission of an application with copy of GDE, if required and a fee of Rs 100 Subject to verification of application.
- Minimum 75%attendance in regular class room lectures and Library class.
- **↓** 100% attendance in seminar, Moot Courts visits.
- 100% attendance in terminal test.
- 100% attendance in educational tour, legal awareness camp and field project.
- ♣ The Director / principal or Vice principal will adopt strict measures is case of identification of indiscipline, immoral, unethical and improper behavior on the part of any student.
- ♣ Up to date payment is required to be made or receipt of payment is to be produced for obtaining college Provisional Certificate, Railway concession, college leaving certificates and avail identity card and fees card etc.
